Benefits

Donors at various giving levels receive benefits as recognition and engagement opportunities. Donors can pay for the benefits they receive (e.g. tickets to the Crystal Awards). In accordance with CRA regulations, the value of benefits at the particular level of donation is deducted from the total gift. The official tax receipt amount is determined by subtracting the fair market value of said benefits, if any from the donation amount. *The donor may chose to waive the benefits in lieu of a charitable tax receipt if desired.*
